KEY OPERATING DATA OF 2022 THIRD QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2022 third quarter of the Company and its subsidiaries (collectively, the “**Group**”).

NEW ENERGY BUSINESS SEGMENT

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2022 third quarter amounted to 2,379,097.67 MWh, representing an increase of 23.36% over the corresponding period of 2021; the on-grid power generation amounted to 2,317,081.39 MWh, representing an increase of 23.71% over the corresponding period of 2021. As of 30 September 2022, the accumulated power generation amounted to 10,040,173.73 MWh, representing an increase of 4.96% over the corresponding period of 2021; the accumulated on-grid power generation amounted to 9,800,560.78 MWh, representing an increase of 5.04% over the corresponding period of 2021. From January to September 2022, the average on-grid tariff (tax exclusive) of the Company was RMB0.45/KWh, representing a decrease of 5.85% over the corresponding period of 2021; the Group’s transacted electricity volume in the electricity market amounted to 2,136,559.15 MWh, the proportion of transacted electricity volume in the electricity market amounted to 21.80%, representing an increase of 11.70 percentage points over the corresponding period of 2021.

GAS BUSINESS SEGMENT

According to the Company's preliminary statistics, the transmission volume of gas of the Group on a consolidated basis for the 2022 third quarter amounted to 713,421,500 cubic meters, representing an increase of 8.14% over the corresponding period of 2021, of which, the sales volume of gas amounted to 590,881,700 cubic meters, representing a decrease of 0.24% over the corresponding period of 2021; the volume of gases transported by the Group for its client amounted to 122,539,800 cubic meters, representing an increase of 81.74% over the corresponding period of 2021. As of 30 September 2022, the accumulated transmission volume of gas amounted to 3,169,127,400 cubic meters, representing an

increase of 7.40% over the corresponding period of 2021, of which, sales volume of gas amounted to 2,778,060,000 cubic meters, representing an increase of 2.29% over the corresponding period of 2021, the volume of gases transported by the Group for its client amounted to 391,067,500 cubic meters, representing an increase 66.42% over the corresponding period of 2021.
