### **KEY OPERATING DATA OF APRIL 2025**

This announcement is made by China Suntien Green Energy Corporation Limited (the “**Company**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

According to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for April 2025 amounted to 1,477,832.60 MWh, representing a year-on-year increase of 16.91%. As at 30 April 2025, the accumulated power generation amounted to 6,022,021.31 MWh, representing a year-on-year increase of 11.91%.

According to the Company's preliminary statistics, the transmission/sales volume of gas of the Group on a consolidated basis for April 2025 amounted to 350.1609 million cubic meters, representing a year-on-year decrease of 16.60%, of which, the sales volume of gas amounted to 330.8875 million cubic meters, representing a year-on-year decrease of 12.88%; the volume of gas transported by the Group for its clients amounted to 19.2734 million cubic meters, representing a year-on-year decrease of 51.89%. As at 30 April 2025, the accumulated transmission/sales volume of gas amounted to 2,197.1410 million cubic meters, representing a year-on-year decrease of 17.09%, of which, sales volume of gas amounted to 2,015.0579 million cubic meters, representing a year-on-year decrease of 14.85%; the volume of gas transported by the Group for its clients amounted to 182.0830 million cubic meters, representing a year-on-year decrease of 35.78%.
