KEY OPERATING DATA OF 2025 FIRST QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2025 first quarter of the Company and its subsidiaries (collectively, the “**Group**”).

NEW ENERGY BUSINESS SEGMENT

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2025 first quarter amounted to 4,544,188.70 MWh, representing an increase of 10.37% over the corresponding period of 2024; the on-grid power generation amounted to 4,442,621.49 MWh, representing an increase of 10.45% over the corresponding period of 2024. As of 31 March 2025, the accumulated power generation amounted to 4,544,188.70 MWh, representing an increase of 10.37% over the corresponding period of 2024; the accumulated on-grid power generation amounted to 4,442,621.49 MWh, representing an increase of 10.45% over the corresponding period of 2024. From January to March 2025, the average on-grid tariff (tax exclusive) of the Group was RMB0.43/KWh, flat as compared with the same period of last year; the Group’s transacted electricity volume in the electricity market amounted to 1,986,200.29 MWh, and the proportion of transacted electricity volume in the electricity market amounted to 44.71%, representing an increase of 9.04 percentage points over the corresponding period of 2024.
